

3. Approve and authorize funding for the Career Technical Education Program (\$2,500,000) from District 3 2nd ARPA allocation under the Economic Recovery category to the Mt. San Jacinto College Foundation; and
4. Direct the Executive Office to Initiate Work on the ARPA Neighborhood Revitalization Project Agreement with City of Temecula, the ARPA Economic Recovery Program Agreement with Impact Riverside County, and the ARPA Economic Recovery Program Agreement with the Mt. San Jacinto College Foundation; and
5. Approve and Authorize funding to the Office of Economic Development (OED) for the French Valley Child Care and Early Childhood Learning Experience Project (\$12,000,000) from District 3 2nd ARPA allocation under the Child Care Facilities category; and
6. Direct the Executive Office to include Necessary Budget Adjustments to Fund the Approved Third District ARPA Projects.

BACKGROUND:

On March 11, 2021, President Biden signed into law a \$1.9 trillion economic stimulus bill also known as the COVID-19 Stimulus Package or the American Rescue Plan Act (ARPA). The intent of the bill is to accelerate the United States recovery from the economic and health impacts of the COVID-19 pandemic. ARPA includes \$362 billion in Coronavirus State and Local Fiscal Recovery Funds (ARPA Fiscal Recovery Funds) for eligible state, local, territorial, and tribal governments. These ARPA Fiscal Recovery Funds can be utilized for four categories of eligible uses:

- a) To respond to the public health emergency or its negative economic impacts, including assistance to households, small businesses, and nonprofits, or aid to impacted industries such as tourism, travel, and hospitality.
- b) To respond to workers performing essential work during the COVID-19 public health emergency by providing premium pay to eligible workers.
- c) For the provision of government services to the extent of the reduction in revenue due to the COVID-19 public health emergency relative to revenues collected in the most recent full fiscal year prior to the emergency; and

d) To make necessary investments in water, sewer, or broadband infrastructure. Riverside County's share of the American Rescue Plan funding is estimated to be \$479 million, of which the first installment of \$239,937,299 was received on May 10, 2021. Funds must be obligated by December 31, 2024 and expended by December 31, 2026. On April 27, 2021, the Executive Office presented the Board of Supervisors with a preliminary ARPA funding allocation and on October 19, 2021, presented a revised funding allocation after the U.S. Treasury released the ARPA interim funding guidelines. The revised allocation included a new category for Child Care. The funding allocation obligates funds to 7 categories: Infrastructure, Housing & Homelessness, Economic Recovery, County Departments Response, Non-Profit Assistance, Child Care and Revenue Backfill. In its final funding guidelines issued on January 6, 2022, the U.S. Treasury broadened the use of the ARPA funds to include disproportionately impacted communities projects to develop neighborhood features that promote improved health and safety outcomes, such as parks, green spaces, recreational facilities, sidewalks, pedestrian safety features such as crosswalks, projects that increase access to healthy foods, streetlights, neighborhood clean-up, and other projects to revitalize public access.

On February 8, 2022, the Board approved establishment of the ARPA infrastructure funding category in the amount of \$82 million. This amount dedicated \$75 million to water, stormwater, and sewer infrastructure projects, distributing \$15 million per District, with the remaining \$7 million being allocated to the Broadband affordability program. A second allocation of \$33 million has been distributed per District to be obligated to qualified projects and programs within all approved categories. The following projects are being recommended for ARPA Third District Second Allocation funding by the Third District, and were determined to be in compliance with ARPA funding objectives and US Treasury eligibility criteria by the Executive Office.

Mike Naggar Community Park

The City of Temecula is proposing to add a 33,000 square foot dog park to the Michael "Mike" Naggar Community Park located at 29119 Margarita Rd, Temecula, CA 92595. Features will include a large dog pen, small dog pen, seating areas, drinking fountains, shade structures, landscaping, and fencing. The park is located within a census designated lowmod block group and will provide residents with access to facilities and amenities that promote outdoor recreation and encourage healthier lifestyles.

The City will administer, construct, and maintain this Neighborhood Revitalization project, which will be completed on or before December of 2026, utilizing a combination of proposed ARPA funding and City funding.

Hiring Our Heroes Program

Hiring Our Heroes is a program that connects the military community, service members, spouses, and veterans, with American businesses to create economic opportunity and a strong diversified workforce. This funding would assist the 501(c)3 organization, Impact Riverside County, in expanding the program.

Career Technical Education (CTE) Program

The CTE will be an innovative K-16 workforce education center located at the Mt San Jacinto College Temecula Campus that provides specific training in a variety of fields including next generation automotive maintenance, healthcare, advanced manufacturing, utilities, and bio-tech. This funding will assist the Mt. San Jacinto College Foundation with expanding the program.

French Valley Childcare and Early Childhood Learning Experience Project

This project proposes to build a 9,000 square foot childcare facility and a 3,400 square foot interactive early childhood development facility connected to the French Valley Library. Early childhood access to educational and library materials has shown to have a major impact on the educational success of youth. This project will assist in the recovery of the education gap experienced during the Covid-19 Pandemic.

The Riverside County Office of Economic Development will administer, construct, and maintain this joint use facility for childcare and early childhood development, in partnership with Riverside County First 5.

Impacts to Residents

The proposed neighborhood revitalization project will improve quality of life and promote healthy lifestyles by improving access to recreational facilities within the County. The proposed economic recovery programs will improve access to employment opportunities for a diverse workforce, and the proposed childcare project provides needed space for childcare facilities and early learning services. These projects and programs all respond to the negative public health and economic impact disparities as enumerated in the ARPA Final Rule.
