OFFICE of PUBLIC GUARDIAN Taking Care of At-Risk Adults

Summary

Public guardianship programs are an important part of the public safety net for atrisk adults who have developmental (cognitive) impairments, and may be subject to abuse, neglect, or exploitation. These individuals are frequently isolated. A noted bioethicist is quoted in Incapacitated and Alone: Health Care Decision-making for the Unbefriended Elderly, "The single greatest category of problems we encounter are those that address the care of decisionally incapable individuals, who have no living relative or friend who can be involved in the decisional-making process. These are the most vulnerable because no one cares deeply if they live or die. We owe these individuals the highest level of ethical and medical scrutiny."

Many at-risk adults may become clients of public guardianship programs, known in Riverside County (County) as the Office of Public Guardian (OPG).

The purpose of this report is twofold: (1) to consider OPG's role in taking care of atrisk adults placed under conservatorship; (2) and to address issues of transparency and accountability identified in the 2022 report commissioned by Riverside County Board of Supervisors.

Background

In 2018, an incident occurred that brought to light several issues within Riverside County departments, which included the Department of Public Social Services (DPSS), Riverside University Health System-Behavioral Health (RUHS-BH), OPG, and Riverside County Counsel.

In October 2021, County executive office leadership, on behalf of the Board of Supervisors (the Board), commissioned the law firm of Larson LLP, to investigate the 2018 incident and provide its findings and recommendations to the Board on what needed to be done to correct the problems. In June 2022, the investigation was completed and a report was submitted to the Board, named *Riverside County Programs and Services for Children in Foster Care, Transitioning Youth, and Adults Under Conservatorship* (Larson report).³ This report addressed key problems related to OPG, among other issues within multiple County departments.

According to the Larson report, OPG cannot share private client information with other County departments, nor with the Riverside County Civil Grand Jury (Grand Jury), due to required compliance with State statutes. As a result, there is a lack of communication, transparency, and accountability across County departments.⁴ This lack of transparency is a consequence of limitations under the same law. For example, the OPG annual external audits regarding Medi-Cal and Social Security are reviewed internally and are not readily available to other County departments, nor to the public, in order to preserve client privacy.⁵

Methodology

The Grand Jury conducted a comprehensive review of OPG through the following methods:

Discussion

Conservatorship and Investigation:

The Riverside County Superior Court (Court) appoints conservators to help conservatees with activities of daily living (ADLs), including assistance with managing finances. The Court may appoint one person to be conservator of both the

person and their estate. The conservator of an estate has a legal and fiduciary responsibility to the client.⁶

Conservatorship is the legal process in which a judge appoints another person (conservator) or agency to make decisions for a person (conservatee) who is incapable of fully managing his or her own affairs. OPG reports that it currently has 1,040 clients under conservatorship.

The conservatorship process always begins with a referral. Anyone can make a referral to the Public Guardian. Referrals come from various sources, including Adult Protective Services (APS), Office on Aging (OOA), convalescent hospitals, acute care hospitals, law enforcement, and private citizens. Interested parties can also petition the Court to become a conservator.⁸

Upon receipt of the referral, OPG opens the case and begins an assessment of the client. There are several types of assessments, including initial visits, quarterly visits, and annual visits. According to the California State Association of Counties, services of the Public Guardian may be "provided through a separate county department, an elected official, or incorporated into a larger department such as health or human services". 9

According to the Judicial Council of California,¹⁰ there are many types of conservatees. Many are elderly, some are young with temporary or permanent mental or physical disabilities that may require assistance with ADLs.

There are many types of conservators. According to the *Judicial Council of California "Handbook for Conservators, 2016"*, what conservators have in common is a willingness to help someone who needs assistance. A conservator might be a family member, domestic partner, or friend. If no one is willing or able to serve, the conservator might be a professional fiduciary or the OPG.¹¹

According to the OPG website: The Public Guardian provides a vital service to persons unable to properly care for themselves or who are unable to manage their finances. The Public Guardian conducts the official County investigation into conservatorship matters and acts as the legally appointed guardian or conservator for persons found by the Superior Courts to be unable to properly care for themselves or their finances.¹²

Below are descriptions of the main components and services of Public Guardian work:

Deputy Public Guardians (DPGs) are responsible for planning, organizing, and performing activities related to OPG's services and functions (conservatorship). Specifically, the DPG activities include the proper care, maintenance, education, and support of the conservatee.¹⁴

OPG has many duties related to conservatorships, outlined on its website, and within the RUHS-BH *Guide to Services*. ¹⁵ These duties are defined by OPG as:

- 1. Conservatorship The Superior Court appoints a manager for the financial and/or personal care needs of the individual who is either physically or mentally unable to provide for those needs.
- 2. Conservatorship Investigation The Public Guardian's office determines whether or not a client should be placed under conservatorship. Investigators gather information from the client's family, therapist, doctors, and anyone else who may be involved with the client. Based on the information obtained, a report is generated with a recommendation for or against conservatorship. The report is then submitted to a judge for the final determination.

Administrative Services:

- 1. LPS/Property Management Administration The Public Guardian has been designated by the County Board of Supervisors as the County office to serve as conservator under the Lanterman-Petris-Short Act (LPS) for persons gravely disabled as the result of a mental disorder. These individuals may require placement in a mental institution or other facility for psychiatric treatment. *Grave disability* is defined as a condition in which a person, as a result of a mental disability, is unable to provide for his/her basic personal needs for food, clothing, or shelter.
- 2. Probate Administration OPG operates under the legal requirements of the Probate Code, providing probate conservatorship services while managing property, and/or providing for the personal care needs of disabled adults.
- **3.** Representative Payee Program (Estate Conservatorship) Many clients find themselves in a position where they are unable to safely handle their finances. In these cases, the Public Guardian has a program whereby a special person, called a payee, is designated to collect the client's Social Security

income. The payee uses those funds to pay the client's bills such as rent, utilities, medical expenses, and other expenses of daily living.

In its investigation of OPG, the Larson report and the Grand Jury identified the following issues:

Organizational Transparency:

As reported by Larson, a lack of transparency and accountability are factors contributing to the problems between the Office of Public Guardian, other County departments, and the public where Larson's attempts to contact OPG leadership were problematic. The Grand Jury, through interviews and research, learned that OPG's organizational structure is not clearly defined and lacks visibility.

The Riverside County website has a Public Guardian page, which has only a brief description of conservatorships. The OPG address, telephone and fax numbers, and office hours, are also listed therein.¹⁶ (see Exhibit 1)

A separate website listed under RUHS-BH, includes an OPG page identifying the Public Guardian Program. This website provides leadership and staff information, and indicates that OPG provides conservatorship investigations and administrative services. An interested party would have to know to look first under RUHS, second Behavioral Health, and finally under Programs in order to find the Public Guardian Program page. Within this website, there is no information about OPG's office address, telephone/fax numbers, and office hours.¹⁷ (see Exhibit 2) These two websites (Riverside County and RUHS-BH) would be more informational regarding OPG if they were linked.

The Larson report described the experience of a provider trying to locate OPG: "There is no information that can be accessible or that is available online to get information. ... So, for me as a provider, that means I have to literally track down somebody's email or call the reception desk multiple times and find a supervisor to help me." ¹⁸

Financial Accountability and Audits:

OPG is a member of the Local Government Association and participates in the County Medi-Cal Administrative Activities and Targeted Case Management Program. This program is part of California Medi-Cal reimbursement for Targeted Case Management. The state and the federal governments conduct annual audits of OPG including Medi-Cal and Social Security. These appear to be the only scheduled external audits reported by OPG leadership. Those audits did not identify any performance review or audit process by an outside entity. The National Guardianship Association requires that "the organization shall undertake an internal program evaluation annually;" and "the organization will arrange to have an external program audit by an objective third party on a biennial basis."²⁰

According to budget information provided by OPG, it manages millions of Federal, State, and County taxpayer dollars and makes decisions influencing the quality of life for over a thousand clients under conservatorship. OPG budgets have increased over the years.²¹

OPG's management of taxpayer dollars should be audited, including financial (internal) and performance (external) audits. The Board of Supervisor's Resolution Number #83-338 details the authority of the Auditor-Controller's Internal Audits, which states under Policy III. A. 3.: "The accounts and records of any department, office, board, or institution under the control of the Board of Supervisors and of any district whose funds are kept in the County treasury shall be audited by the Auditor-Controller as directed by the Board of Supervisors. Government Code §26883."²²

The most recent Internal Audit Report regarding OPG was dated July 31, 2014.²³ There was a follow-up to this report dated November 23, 2016. However, there were no further audits scheduled by the Board of Supervisors regarding OPG, although

California Government Code 25250 requires the County Board of Supervisors to audit, or cause to be audited, departments under its authority.

The June 2022 Larson report identified OPG as one of the financially and/or politically sensitive areas within Riverside County government that needs improvement. In an interview, a County executive officer informed the Grand Jury that the Executive Office can request the Auditor-Controller to add internal audits to the normal two-year internal audit schedule. The Executive Office can also arrange for external audits of financially and/or politically sensitive areas within the County.

The Grand Jury was left with an important unanswered question: If by statute, audits are required for entities managing taxpayer dollars, why is the OPG program not being audited by the County on a regular basis?

Findings

- **F1:** OPG manages millions of Federal, State, and County taxpayer dollars.
- **F2:** The Riverside County Auditor-Controller's office has not conducted an internal audit of OPG since 2014.
- **F3:** The Riverside County Auditor-Controller's planned internal audits do not include OPG.
- **F4:** The Riverside County Auditor-Controller's office is required to audit County departments, offices, boards, and institutions.
- **F5:** OPG is a sensitive program that is not being financially audited internally, nor audited externally, for performance by the County on a regular basis.
- **F6:** OPG is audited annually by the state of California specifically for its use of Medi-Cal funds.
- F7: OPG is audited annually by the federal government specifically for its use of Social Security funds.
- **F8:** The information provided on the Riverside County website regarding Office of Public Guardian has a brief description of conservatorship, which includes the OPG address, telephone/fax numbers, and office hours.

F9: The OPG page is embedded within the Riverside University Health System website.

Recommendations

R1: The Auditor-Controller Office should financially audit OPG on a regular basis according to County policies and procedures.
